

# The Corn Exchange's Christmas Quiz 2016

## Terms and Conditions

Please read the following terms and conditions carefully before entering the draw

### 1. The Prize

- a) All entries will be put into the draw and winners selected at random : 1st Prize = £60 cash, 2nd Prize = £30 cash, 3rd Prize = £10 cash

- f) The result of the draw is final. No correspondence will be entered into.
- g) By entering the draw you agree to these terms and conditions.

### 3. Draw Entries

- a) The Corn Exchange's Christmas Quiz 2016 is open to mainland Great Britain residents aged 16 and over (this excludes Northern Ireland, Isle of Man and Channel Islands and is due to Gambling Commission legislation).
- b) The closing date for entries is **12pm on Monday 9<sup>th</sup> January 2017**. Late entries will be treated as a donation to Corn Exchange (Newbury) Trust.
- c) By entering the draw, you hereby warrant that all information submitted by you in your Entry is true, accurate and complete in every respect. The Corn Exchange (Newbury) Trust reserves the right to verify any information contained in your Entry and/or your eligibility to enter the draw.
- d) Entries must be made by the Closing Date and in the manner set out in the Terms and Conditions. Failure to do so will result in disqualification.

### 4. Donations for Quiz Entry

- c) Charity Aid Foundation vouchers or those funded by Give As You Earn accounts cannot be used as a donation for entry. All CAF payments will be treated solely as a donation.

- a) The winners will be notified after the competition has closed by telephone or by email/ post where a telephone number is not available. If, for any reason, any winner is not contactable four weeks after the quiz closes the winner is disqualified and the draw will be re-drawn.
